**ADDENDUM TO AGREEMENT FOR RECEIPT OF CONSOLIDATED NETWORK B DATA AND AMEX
MARKET DATA: PAYMENT BY THIRD PARTY**

As indicated in the Subscriber Agreement to which the Addendum is attached, the undersigned Subscriber has requested the receipt of Network B market data. Subscriber has also requested that a third party (the undersigned "Payor") be permitted by the Exchange to assume full responsibility for payment of the applicable charges for Subscriber's receipt of the Network B market data.

In consideration for the Exchange's approval of the "third party payment" arrangement, the undersigned parties agree as follows:

1. The Exchange agrees to waive the Subscriber's obligation under the attached Subscriber Agreement to pay the applicable charges for its receipt of Network B market data.
2. Subscriber agrees to comply with all other conditions and obligations of the Subscriber Agreement.
3. Payor for its part agrees to assume full responsibility for payment of the applicable market data charges, Subscriber hereby acknowledging such assumption by Payor. Payor further agrees to promptly notify the Exchange in the event this "third party payment" arrangement between Subscriber and Payor is terminated. Payor acknowledges its continuing responsibility for payment of all market data charges incurred and unpaid on the date such termination is received by the Exchange.
4. In the event the Exchange is notified by Payor of the termination of the "third party payment" arrangement, the Exchange will in turn notify the Subscriber that unless the Exchange is promptly notified to discontinue the market data service to Subscriber, such service will be continued to Subscriber, with Subscriber thereafter being fully responsible for payment of all applicable charges.
5. Absent notice of termination of the "third party payment" arrangement, in the event Payor simply fails to pay any applicable charge due and outstanding, the Exchange will notify both the Payor and Subscriber that it will discontinue market data service to Subscriber unless Payor promptly remits full payment of such outstanding amount to the Exchange.
